Dear Mr Suresh Kumar,

India Foundation for the Arts (IFA) had made a grant of Rs 5,00,000/- (Rupees Five Lakh only) to enable you to document the work of 180 contemporary visual artists in and around Bangalore under IFA's Extending Arts Practice programme. The grant period was from 31.03.2013 to 30.09.2014

Midway through/your grant on August 18.8.2014 at a meeting at IFA with the programme executive and me, you gave reasons for the delay on your work and upon your request we extended the term of your grant for eight months ending 31.05.2015. At that point we had shown grave concern regarding the progress of the grant since very little was achieved till then. According to your financial report Rs 1,15,750/- of the first instalment of Rs 2,50,000/- was still unspent. You had assured us that you would work seriously towards the completion of the project. A letter dated 20.09.2014 was sent informing you about the extension.

However, we are very disheartened to see that at the end of the grant period nothing has progressed. In fact you have not maintained any contact with the programme executive in spite of repeated attempts at communication. This is a breach of trust that is unexpected from you given your relationship with the organisation. Thus we are compelled to terminate the grant with immediate effect.

As per your interim financial report there was an unspent grant amount of Rs 1,15,750/- lying with you. We request you to return the unutilized grant amount of Rs 1,15,750/- by way of cheque favouring India Foundation for the Arts by July 15, 2015.
